This course, *Firefighter Training, S-130* and *Introduction to Wildland Fire Behavior, S-190*, are required training for all personnel prior to certification as a Firefighter (FFT2) under the Wildland Fire Qualification System Guide (PMS) 310-1. An adapted version of L-180, "Human Factors on the Fireline," has been included as part of this course. This entry-level course for all new firefighters can also be used as a refresher course for returning firefighters. The purpose of this course is to train new firefighters in basic firefighting skills. Firefighters who successfully complete this course and the Work Capacity Test are qualified to suppress wildland fires while under close supervision. Students that successfully complete S-130 should also be given credit and a certificate for completing L-180, "Human Factors on the Fireline."

Introduction to Wildland Fire Behavior, S-190 is a six- to eight-hour course designed to meet the training needs of a Firefighter Type 2 (FFT2) on an incident as outlined in the Wildland Fire Qualification System Guide, PMS 310-1, and the Position Task Book (PTB) developed for the position. The Wildland Fire Qualification System Guide (PMS) 310-1 provides guidance and a national wildfire standard for establishing minimum training, skills, knowledge, experience, and physical fitness requirements for the participating agencies of the National Wildfire Cooperating Group (NWCG). This course allows instructors to utilize the most recent Incident Response Pocket Guide (IRPG) and Fireline Handbook (FHB) — Appendix B to illustrate and emphasize various points throughout the course.
