It should assist jurisdiction personnel with implementing appropriate processes and procedures for the entire disaster timeline prior to a disaster taking place to help maximize reimbursement potential. This course includes live, instructor-led presentations, interactive breakout sessions, and a disaster documentation simulation.	24 hrs.

Sept 19-20, 2024 Thu/Fri 8a-5p	0	The course combines one day of classroom instruction followed by a second day in the field with students working through a series of problem solving events in small teams. Topics include leadership values and principles, transition challenges for new leaders, situational leadership, team cohesion factors, ethical decision-making, and after action review techniques.  Prerequisite: Successful completion of L-180, Human Factors in the Wildland Fire Service. Successful completion of pre-course work. Pre-Course work will be sent to registered students by Texas A&M Forest Service.	16 hrs.

Prerequisites: Qualified as any single resource boss.  Successful completion of pre-course work.  Pre-Course work will be sent to registered students by Texas A&M Forest Service	16 hrs.

Sept 19-20, 2024 Thu 8a-5p Fri 8a-12p	0	This course is designed to provide students with the knowledge and skills to perform the duties of the Crew Boss (CRWB) position, as described in the NWCG Incident Position Standards for Crew Boss. Topics include travel and check-in, briefings, assigning tasks and assessing crew performance, implementing fire line duties, mop-up, firing operations, using aerial resources, medical emergencies, and wildland urban interface.  Prerequisites: Students must complete Online Training (OLT) prior to being admitted in the Instructor-Led Training (ILT). Students must submit the completed memo/certificate before the ILT course starts (not day of) to be admitted in the class.  Texas A&M Forest Service will email participants the Online training information/Instructions. Students will send completed Online training memo/certificate to Texas A&M Forest Service.  Qualified as Firefighter Type 1 (FFT1).  Successful completion of Intermediate Wildland Fire Behavior (S-290).	12 hrs.

Sept 19-20, 2024 Thu/Fri 8a-5p	0	This course is designed to produce student proficiency in the performance of the duties associated with engine boss, single resource (ENGB). Topics include engine and crew capabilities and limitations, information sources, fire sizeup considerations, tactics, and wildland/urban interface.  Prerequisites: Qualified as a Firefighter Type 1 (FFT1). Successful completion of S-230, Crew Boss (Single Resource) (CRWB)	16 hrs.

Sept 19-21, 2024  Thu/Fri 8a-5p Sat 8a-12p	0	This course is designed to meet the training requirements outlined in NIMS: Wildland Fire Qualification System Guide, PMS 310-1 and the position task books developed for the positions of Task Force Leader and Strike Team Leader.  Prerequisites: Qualified as any single resource boss.  Pre-Course work will be sent to registered students by Texas A&M Forest Service.	20 hrs.

Sept 19-21, 2024 Thu/Fri/Sat 8a-5p	0	Instructional units include firefighter safety in the interface, managing human factors in the interface, pre-incident planning, size up and initial strategy, structure triage, structure protection overview, tactics in the interface, tactical operations and resource use in the interface, action assessment, plan update, and after action review.  Prerequisites: Qualified as a FFT1 (wildland)	24 hrs.

Sept 19-21, 2024  Thu/Fri 8a-5p Sat 8a-12p	5	The course discusses and illustrates common firing devices and techniques. The course work is not a substitute for the dynamic fire environment. The course provides students with important information regarding general tasks required to be successful. Any opportunity to show students a real ignition or demonstrate the use of an actual firing device will assist in transferring these new concepts and skills to the job.  Prerequisite: Qualified as a FFT2 Students must complete Online Training (OLT) prior to being admitted in the Instructor-Led Training (ILT). Students must submit the completed memo/certificate before the ILT course starts (not day of) to be admitted in the class.  Texas A&M Forest Service will email participants the Online training information/Instructions. Students will send completed Online training memo/certificate to Texas A&M Forest Service.  PPE NFPA 1977 FF ensemble eye protection, ear protection, gloves, fire pack w/ shelter.	20 hrs.
S-339 – Division / Group Supervisor FEE - \$250.00 Student Limit - 25  TEEX FP ARE133 39 R https://tinyurl.com/98rr6wse All classes and Symposium sessions include lunch.	Sept 19-21, 2024  Thu/Fri 8a-5p Sat 8a-12p	0	This course prepares students to perform in the role of Division/Group Supervisor (DIVS). Topics include division or group management, organizational interaction, division operations, all-hazard operations, and tactical decision.  Prerequisites: Qualified as a Task Force Leader or ICT3, or ICT4 AND any two Strike Team Leader positions (one must be STCR or STEN) Successful completion of pre-course work. Pre-Course work will be sent to registered students by Texas A&M Forest Service.	20 hrs.
