Prerequisites

Five years of documented **Command Staff Administration Experience** in emergency services administration **and a bachelor's degree (or higher) in a related field** (see definition of Command Staff Administration Experience below). The applicant's command-level administrative experience **must** be documented as part of the application process. The applicant shall submit a narrative explanation that details the applicant's relative experience that supports the experience listed within the submitted resume and how that experience meets the requirements for Track-B application to the Fire Service Chief Executive Officer Program (FSCEO).

Note: The applicant's Bachelor's degree (or higher) must be conferred by a regional or national accredited institution.
