

# FAQS

**1. Is the cost of the hotel included in the cost of the tuition?**

*The cost of the hotel is not included in the cost of tuition. Students are responsible for covering the cost of travel including their lodging.*

**2. Are meals included in the cost of tuition?**

*Some meals are included in the cost of tuition. Breakfast is provided by the hotel and lunch is provided by the program. Students are responsible for dinner.*

**3. When can I register for the program?**

*FSCEO has a specific application process which can be found on the program's description page. Typically, the application process will be open for a few months prior to the start of the program. The application period is one month long once open.*

**4. Do I need to attend class every day?**

*Yes, class attendance is required 100% of the time.*

**5. Where will classes be held?**

*Classes will be held at Texas A&M Mays Business School in the Center for Executive Development located in the new **Wayne Roberts Building**. The address is 256 Olsen Blvd., Suite 400, College Station, TX 77843*

**6. Will parking be provided?**

*Parking is free of charge at the hotel; however, it costs \$15 per day at Mays Business School. It is recommended that the student not drive their vehicle to class each day but instead take the charter bus with the program. Please note, the hotel does have a parking garage but it will not fit vehicles over the standard height. There is limited surface lot parking at the hotel if your vehicle will not fit in the parking garage.*

**7. Am I required to stay at the host hotel?**

*No, but it is strongly recommended that students stay at the host hotel. The charter bus will only pick up and drop off at the host hotel.*

**8. Will the hotel rooms be offered at the State Rate?**

*We cannot always guarantee that the hotel will be at the state rate, but we try our best to get as close to the state rate as possible.*

**9. What is the required attire? Do I have to wear a uniform?**

*For classroom activities, students should wear their duty uniform or business casual. For graduation, students should wear their Class A uniform or business professional.*

**10. Can I apply HB2604 funds toward the tuition of this course?**

*Yes, but it can only reimburse \$665 of the total expense.*
