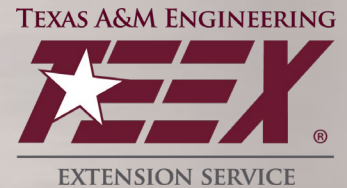


Len Jenicek
