<u>Please pay close attention to the following</u>

RISK RELEASE: Each student will be asked to sign a Risk Release form upon arriving to class. To review a copy please visit our web site at <u>www.teex.org/lng</u>

INVOICING: If you would like for us to invoice your company, please provide a Purchase Order at least two weeks prior to class start date.

DRESS:

- Clothing will be normal, everyday outdoor work attire.
- Full-length pants are required for all participants; shorts are strictly prohibited for any type of training outside the classroom.
- Short sleeve shirts are allowed, but sleeveless shirts are prohibited.
- Close-toed shoes must be worn at all times, regardless of classroom or exterior training exercises.

IMPORTANT POLICY INFORMATION – PLEASE REVIEW

Class dates and locations are subject to change. Therefore, we <u>recommend that you do not</u> purchase nonrefundable travel tickets. If you cannot attend a class, you must contact TEEX in advance to either transfer or cancel your registration. Please refer to the Transfer, Cancellation/Refund, and No-Show Policies below.

Transfers: Transfers are accepted to another scheduled class any time prior to the start of class at no charge.

- Customers are encouraged to transfer to a future scheduled class of the same course.
- If the customer cannot transfer to a scheduled class of the same course, then he/she may transfer to another class of a different course and receive either a refund or pay the difference between the two class fees (if applicable).

• If the customer cannot attend any scheduled class, then the Cancellation/Refund Policy is in effect. **Cancellations/Refunds**

- TEEX will provide a full refund if you cancel 15 or more calendar days before the start of the class.
- Cancellations received 14 calendar days or less before the start of the class will be charged a fee of 10% of the class tuition.
- If TEEX cancels a class, customers will be offered: 1) a transfer to a scheduled class of the same course, 2) a transfer to another class of a different course (customers will receive either a refund or pay the difference between the two class fees, if applicable), or 3) a full refund.

No Shows: Registered participants who do not contact TEEX in advance to cancel their registration and do not attend their scheduled class will be charged the entire class fee.
